Magarpatta Property Unit- Holders Limited who intend to get appointed as Directors retiring by rotation in the said company have to note the following points for eligibility and the criteria for them to become eligible to be appointed on the board of directors.
  - 1. The appointee as proposing himself/ herself as a Director retiring by rotation, should be the owner of the unit at Magarpatta Township at Hadapsar, holding shares of the Company in his name (as representing the unit) and further shall be mandatorily residing/ occupying the unit in the Township by himself/ herself.

- 5. That the His/her Appointment as a Director on the Board will be in accordance with the provisions of Articles of Association of the Company.
- C. The management has decided that in order to ensure have proper representation and a step for Woman empowerment, it is proposed that 1/3rd of the total number of Board of Directors of the Company in the open category (excluding the 5 directors to be nominated by Magarpatta Township Development & Construction Company Limited) will be reserved only for women.
